- Knowingly or recklessly providing information that is false or misleading in notifying the Parish clerk of a Disclosable Pecuniary Interest or in disclosing such interest to a meeting

and that any breach of these regulations in the above terms can be referred to the Police and or the Director of Public Prosecutions for criminal proceedings.
